A few answers to the most commonly asked questions about service of process and Treasure Coast Process Servers:

01 What is Service of Process?

The Florida legal procedure that requires each party in a case be notified if actions are taken against them in a court of law.

People are notified of actions against them or court procedures involving them through the delivery of legal documents such as summons, complaints, subpoenas, order to show cause, and writs.

02 How Long Does it Take to Get Papers Served?

Our turn-around-time varies depending on your requirements. This is something that is determined by you, quicker service leads to a higher cost:

- * Same Day Service
- * Rush Service
First attempt usually within 1 day
- * Routine Service
First attempt with 2-4 days

03 Are you licensed and bonded?

As per Florida Statue, all process servers at Treasure Coast Process Servers are licensed, registered with the county and have posted a surety bond.
